PUBLIC FUNDING FOR MAPS

The study analysed the public funding for the sector of MAPs, at the level of primary production and processing. Piedmont and Valle d'Aosta regions (Northwest of Italy), were the area of research [1]. Were considered the funding provided by the laws of the European Union (E.U.), or by national and regional laws [1]. The aim of the study were: quantify the amount of the funding for these crops; the beneficiaries; the interventions put in place. Data were drawn from regional databases [3,4], and from the national database dedicated to the agricultural sector[5]. Synthetically: government subsidies intended for MAPs were part of broader interventions related to support the rural development; public funds were especially used to develop the cultivation of MAPs, and improve the quality of production.
